## PROPOSED NEW TRAFFIC REGULATION FOR ACOL

For those of you who may not have seen the following, I replicate the Traffic Regulation Order to extend the existing 7.5t weight limit in Plumstone Road and Crispe Road to the rest of Acol Village (Minster Road, The Street, Acol Hill, Margate Hill).

#### THE KENT COUNTY COUNCIL (VARIOUS ROADS, ACOL, DISTRICT OF THANET) (7.5 TONNE WEIGHT RESTRICTION) ORDER 2022 Road Traffic Regulation Act 1984

Notice is hereby given that the Kent County Council in exercise of the powers under Sections 1, 2 and 3(2) of the Road Traffic Regulation Act 1984 (the Act of 1984), as amended, and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, propose to make the following Order:-

The general effect of this Order is to prevent any goods vehicles with a maximum permissible laden weight of which exceeds 7.5 tonne to proceed in those lengths of road specified in the Schedule of the Order and exemptions are provided in the Order for access etc.

Roads in Acol subject to a 7.5 Tonne Weight Limit Restriction as stated below:-ACOL HILL, CRISPE ROAD, DILNOT LANE, MARGATE HILL, MINSTER ROAD, NURSERY FIELDS, PLUMSTONE ROAD and THE STREET – For their entire length.

## THE KENT COUNTY COUNCIL (VARIOUS ROADS, ACOL, DISTRICT OF THANET)

#### (7.5 TONNE WEIGHT RESTRICTION) ORDER 2022 ROAD TRAFFIC REGULATION ACT 1984

The Kent County Council, acting as the Local Traffic Authority intends to make the Order to prohibit any goods vehicle with a maximum gross weight capable of exceeding 7.5 tonnes to proceed on Various Roads in Acol, Thanet as described in the Order.

The reasons for introducing the restriction is to reduce the amount of unnecessary through traffic by large vehicles to prevent danger to persons especially pedestrians, prevent damage to the roads and buildings and preserving the amenities of the area.

The scheme and its objectives meet with one of the central themes in Kent's Local Transport Plan 3 Enjoying Life in Kent (Improve Quality of Life) and Objective 3 of Kent's Freight Action Plan "To effectively manage the routing of HGV traffic to ensure that such movements remain on the Strategic Road Network for as much of their journey as possible" and Objective 4 "To take steps to address problems caused by freight traffic to communities".

As part of the recommendation to make the Order is to avoid the potential of large vehicles attempting to use less suitable routes.

- For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising.
- For preserving or improving the amenities of the area through which the road runs.
- For preventing damage to the road or to any building on or near the road.
- For facilitating the passage on the road or any other road of any class of traffic (including pedestrians).

Various other details and explanations are available online in the full proposal, including the following:

- 2. Save as provided for in Article 3 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform, cause or permit any heavy commercial vehicle in excess of 7.5 tonnes maximum gross weight to proceed along the length of roads specified in the Schedule to this Order.
- 3 Nothing in Article 2 of this Order shall make it unlawful for any person to cause or permit a heavy commercial vehicle to proceed along the length of road specified in the Schedule of this Order (hereinafter referred to as "the road") if the said vehicle is being used:-
  - (a) as a public service vehicle within the meaning of the Public Passenger Vehicles Act 1981, section 1;
  - (b) for or in connection with the conveyance of persons, goods or Merchandise to or from any premises situated on or adjacent to the road specified in the Schedule.

- (c) in connection with any building operation or demolition in or adjacent to the road or the removal of any obstruction to traffic in the road,
- d) in connection with the maintenance, improvement, or reconstruction of the road,
- (e) in connection with the laying, erection, or alteration or repair in or adjacent to the road of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of telecommunications apparatus.
- (f) in the service of the Kent County Council in pursuance of their statutory powers or duties
- (g) for police, fire brigade or ambulance, coast guard or civil defence purpose.
